Brimfield Township, City of Tallmadge, Portage County, Ohio**

The Portage County Engineer's Office will be holding an Open House Public Involvement Meeting to collect public comments for a proposed project located at the IR 76/Tallmadge Road Interchange and its surrounding area. The purpose of this open-house public involvement meeting is to present information and solicit public comments for proposed transportation improvement alternatives at the Interstate Route 76 (I-76)/Tallmadge Road/Mogadore Road interchange and Tallmadge Road between Highway View Drive and I-76. This transportation improvement project proposes to improve mobility, traffic flow and safety, and preserve the existing transportation facilities and connectivity with IR 76. Proposed transportation improvements include:

- Constructing an additional lane on the eastbound I-76 exit ramp to Tallmadge Road including reconstructing the traffic signal.
- Constructing an additional lane on Tallmadge Road from west of Highway View Drive to I-76.

In addition, the proposed improvement will also include one of the following options:

Option 1

- Realignment of the westbound I-76 exit ramp to connect to Mogadore Road north of Tallmadge Road.
- Widening Mogadore Road north of Tallmadge Road.
- Reconstruction of the Mogadore Road (North)/Tallmadge Road Intersection including reconstructing the traffic signal.

Option 2

- Removal of the intersection of Mogadore Road and eastbound I-76 exit ramp by rerouting Mogadore Road from its intersection with Sunnybrook Road to the intersection of Tallmadge Road and Highway View Drive including a new traffic signal.
- Addition of a cul-de-sac on Mogadore Road (North) near the westbound I-76 exit ramp.
