The **Board** decides to discuss Section 700.10.C Illumination of Signs at the next meeting.

The **Board** discusses the proposed changes to Section 510.10 Swimming Pools. One change was changing the height requirement of the fence from six (6) feet to the proposed four (4) feet; the Board agrees on this change. Further is discussed adding to Section 510.10.A. a number five section as follows: Portable swimming pools must meet Section 510.10.A. 1 through 4 requirements or be removed by October 1st and have a removable ladder." Further research and discussion next month; also looking into additional definitions for temporary pools and portable pools.

The **Board** discusses the placement adding 'shipping/storage containers' to the Zoning Resolution; the **Board** decided on adding the proposed language to Section 530.03: Temporary buildings, shipping/storage containers, construction trailers, equipment, and material used in conjunction with construction work only may be permitted in any district during the period construction work is in progress, but such temporary facilities shall be removed upon completion of the construction work.
