**APPLICATION FOR CONSUMPTION OF ALCOHOL**

I, the undersigned renter, do agree to the following terms of this application for consumption of alcoholic beverages inside Community Center located at 4538 Edson Road in Brimfield Township, Ohio 44240.

- A. An Alcohol Use Deposit in the amount of \$100.00/\$200.00 will be posted by me to cover the circumstances that may occur during my use of said facilities, understanding that all or part of the deposit(s) could be retained for violation of any of the stated rules herein as well as additional charges that may be levied to cover costs of excessive cleaning or damages to the facility, equipment or grounds. The Alcohol Use Deposit is a separate deposit from the fee to hire a Brimfield Police officer for your event.
- B. The individual renting the facility is responsible for the cost of a police officer who must be present during the rental period when alcohol is being served. To ensure the availability of an officer for the specified date, arrangements must be made no less than two weeks before the rental date and proof must be presented to the Parks and Recreation Director prior to rental. It is the responsibility of the renter to make arrangements for an officer to be present at their event. Payment will be made directly to the Brimfield Police Department at their current hourly rate. Officer must be hired for a minimum of four (4) hours.
- C. The Township assumes no duty of supervision in the provision of alcoholic beverages and the applicant agrees to hold the Township, it's agents and employees, harmless, fully indemnify and assumes any and all host liability or other liability to guests, invitees, relatives, friends or third parties who may be injured directly and proximately by the provision of alcoholic beverages, of any sort whatsoever, whether for profit, not for profit, or purely such reasons whether the same result from intoxication or are contributed to by intoxication.
